**I. EDUCATION – Mr. Daniel Doyle, *Chairperson***

Recommend the Board approve the Midland After School Clubs for students in grades 6<sup>th</sup> – 8<sup>th</sup>. Each Club will meet one day every month from 2:30 pm – 3:30 pm. The following clubs will be offered and a staff stipend to be determined pending grant funding and Board approval.

**II. FINANCE – Mr. Anthony D'Itri, *Chairperson***

Recommend the Board approve the MOU with Dr. Mitchell Pfeiffer, Internal Medicine Specialist, to provide School Medical Services for the MBSD students. Dr. Pfeiffer will also provide signatures for yearly orders, prescriptions and authorizations for SBAP (School Based Access Program) services throughout the school year. The contract amount is \$3,000 effective 8/1/2025-6/30/2026.

**III. PERSONNEL – Mr. Ray McShane, *Chairperson***

Recommend the Board approve the Salary and Fringe Benefits Agreement between the Board of School Directors of the Midland Borough School District and the Midland Education Association PSEA-NEA from 09/01/2025 – 08/31/2029.

Recommend the Board approve hiring Ms. Roberta Lydick as a day-to-day substitute teacher for the District for the 2025-2026 academic year effective September 2, 2025. Ms. Lydick will receive \$125.00 per day and no healthcare benefits are included with this position. She will be covering for faculty leaves and absences on an as-needed basis.

Recommend the Board approve hiring Mr. Kerry Bowser as a day-to-day substitute teacher for the District for the 2025-2026 academic year effective September 8, 2025. Mr. Bowser will receive \$125 per day and no healthcare benefits are included with this position. He will be covering for faculty leaves and absences on an as-needed basis.

Recommend the Board approve for Beth Ann Calahan, School Nurse, to schedule the annual influenza vaccine clinic for staff through Hometown Pharmacy. The event will take place in October and will be held in the Nurse's office of the Midland Elementary-Middle School.
